# What is LTAMC?

- 'Living together as a married couple' (LTAMC) is a status that affects benefits calculations and entitlement.
- In essence, if you are cohabiting with a partner (same or opposite sex), you are treated as married for benefits purposes.
- This means that means-tested benefits will be calculated based on your combined income and capital.



 Your partner's employment status will be considered when your entitlement is assessed for many forms of benefit.

# How do the court interpret LTAMC?

Mr Commissioner Howell QC described LTAMC decisions as...

one of the most difficult problems of definition there could be, since it involves investigating and analysing the nature of a human relationship between two people and this is inevitably a complex and sensitive thing.

 There are no definitive criteria for LTAMC in law – each case must be decided on its own particulars – but there are a couple of assessments the court might use to work towards an answer to whether you are LTAMC.

### Two standard LTAMC assessments

The three-part assessment looks at the nature of the relationship with respect to...

1. Sex,

- 2. Finances, and
- 3. in general

Neither of these tests is definitive – Every relationship is different – But the court will often consider One or both of these tests when Making a decision. The six signposts test looks at each of...

- a) Membership of the same household
- b) Stability
- c) Financial support
- d) Sexual relationship
- e) Children
- f) Public acknowledgement

 That's for you and the Department for Work and Pensions (DWP) to decide – though DWP usually have the final say.

If in doubt, notify the DWP and ask them to assess whether you count as LTAMC. If you don't like their decision, you have the right to appeal it.

## Are you LTAMC?

If you fail to disclose a cohabitational relationship that DWP consider LTAMC, you could be liable for overpayment repayment, as well as civil charges, and possibly even criminal prosecution.
